### PARENT PLUS LOAN LIMITS

The maximum PLUS loan amount you can borrow is up to your student's cost of attendance at Big Bend Community College minus any other financial assistance your student receives. For help determining your student's eligibility, please call the Financial Aid Department at 509-793-2088 or log in to the student's CTC Link account to view the student's cost of attendance and award offers.

~The student **must have a completed & processed FAFSA** on file for loan request processing. Student **must be in good academic standing** to receive any financial aid, including Federal Direct Loans of any kind.

~ If your student is attending BBCC and in the Commercial Pilot Program, you can contact the Aviation Program Coordinator to learn about flight fees and amounts needed to complete flight hours each quarter.
